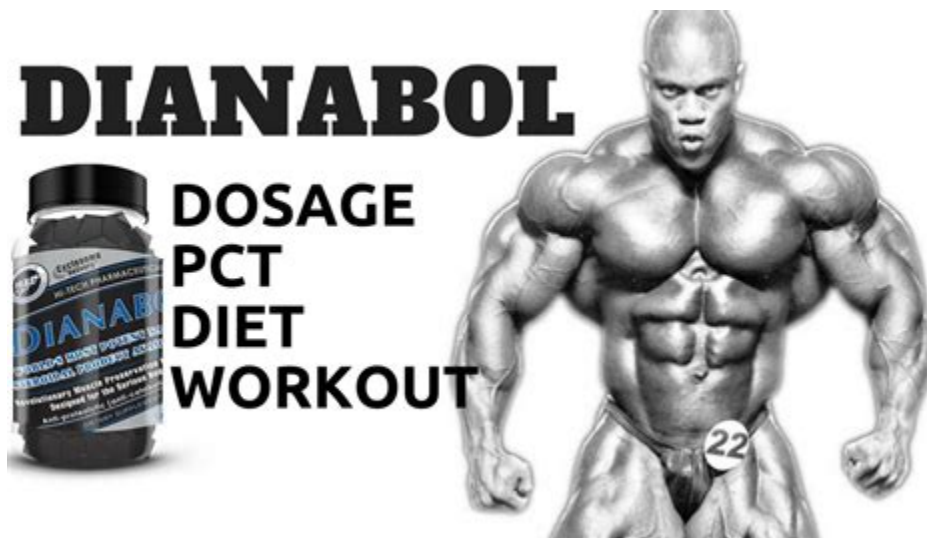

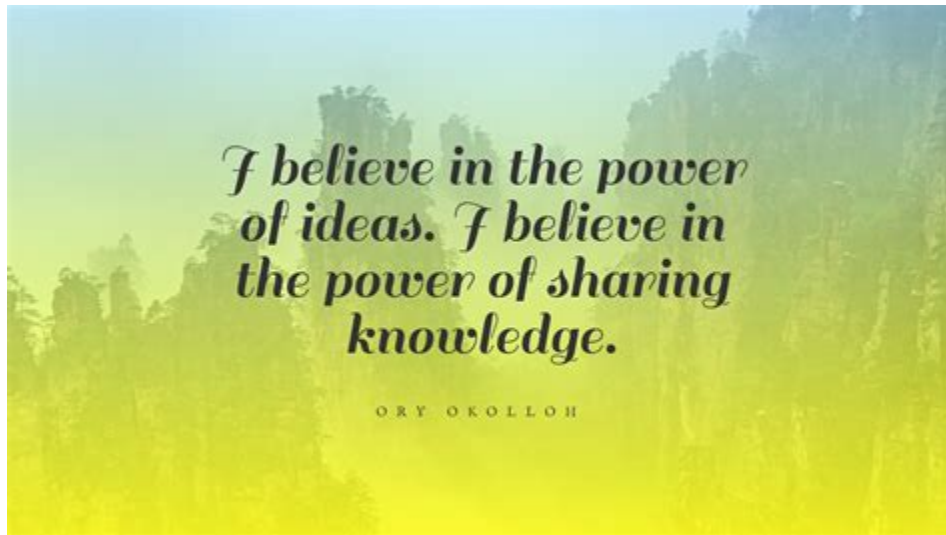

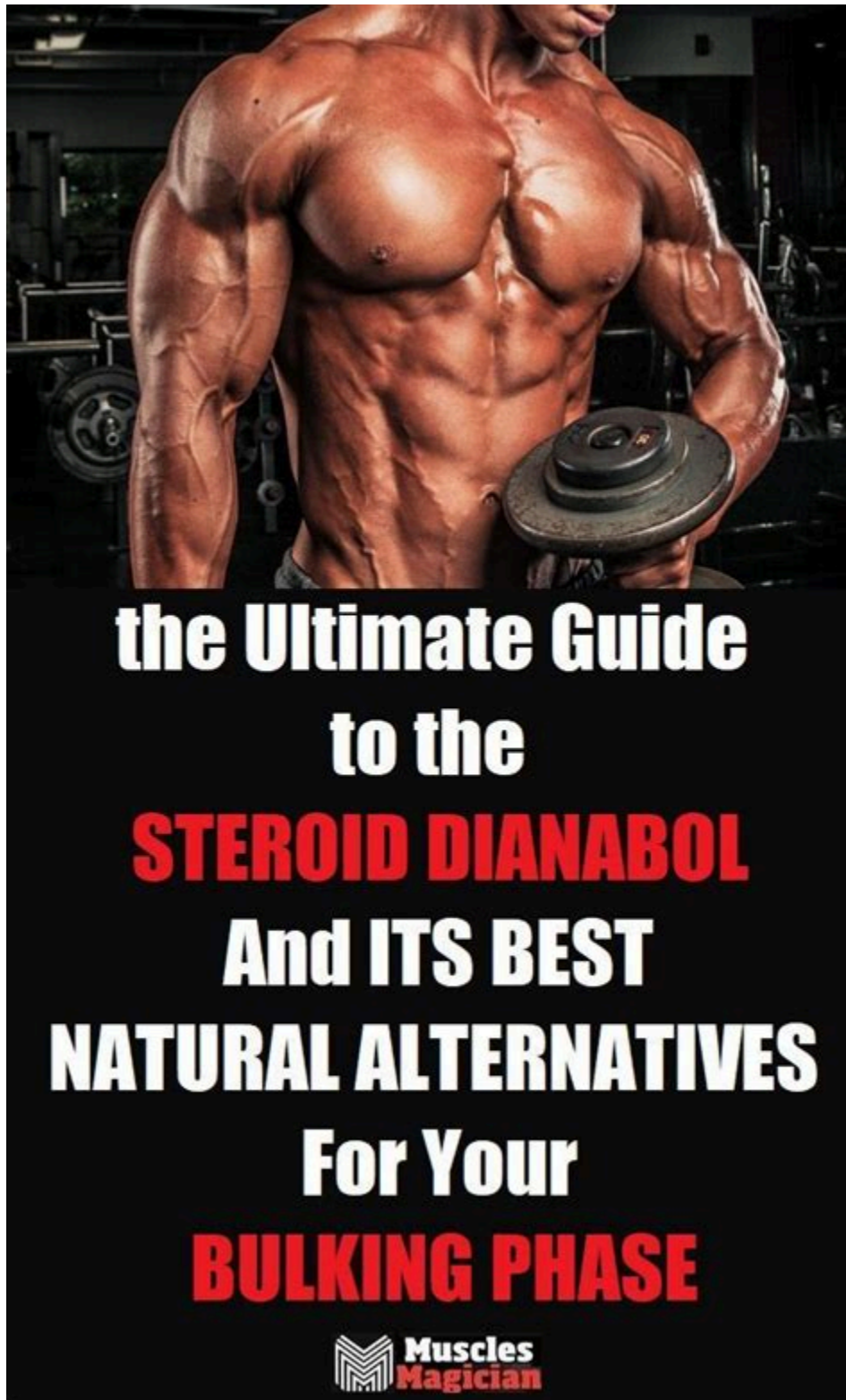

Dianabol became illegal in the United States in 1990 when it was added to the list of controlled substances under the Controlled Substances Act. Other countries have also made Dianabol illegal over time as well, with Canada adding it to its list of controlled substances in 1991 and the United Kingdom

making it a Class C drug in 1997.
